Our core activity is identifying knowledge and technologies at the University of Maribor with commercial potential. We assist UM researchers in intellectual property protection, marketing strategy development and commercialization of their research results.

Our aim is to enhance cooperation between the University and the industry through establishing new contacts with companies home and abroad. This is achieved through various partner networks, such as Enterprise Europe Network, Danube Transfer Center, DEMOLA and others. We help researchers of the University of Maribor to achieve greater visibility and a greater impact of research results, which are increasingly important factors in obtaining funding for research work.

Together we ensure that research is adequately protected with industrial property rights prior to its public announcement. Adequately protected knowledge and technologies are then marketed to national and foreign companies with licensing, concluding new contracts for development and research activities or establishing spin-off companies.


Entry point of the Danube Transfer Centre Network











FOR RESEARCHERS




SUPPORT IN THE RESEARCH AND DEVELOPMENT PHASE

- We offer comprehensive support in the process for protecting the invention with industrial property rights of the University of Maribor.
- We monitor and keep records of existent industrial property rights of the University of Maribor.
- We offer assistance in regulating relations between the University of Maribor and its research partners.
