- □ The certificate of completion of all study obligations or official proof of passed exams and practical courses with grades in the time of applying as well as the number of all graded units or study obligations under the second-cycle study programme or education which corresponds to the level of education obtained under second-cycle study programmes and is, in accordance with the law regulating the Slovene qualifications framework, ranked to level 8 or a comparable study programme obtained abroad.

Personal data will be used for the purpose of reporting to ARIS. It will also be forwarded or made available to the competent supervisory authorities in the event of an audit or inspection.

The personal data of non-selected candidates will be stored until the expiry of deadlines for exercising the rights or until storage is required by possible sectoral regulations and personal data of selected candidates will be stored in accordance with the applicable legislation.
